RESTRICTION OF FLYING REGULATIONS - HER MAJESTY THE QUEEN'S BIRTHDAY FLYPAST REHEARSALS - 3 TO 5 JUNE 2019

- 1** A large formation of military aircraft will form Her Majesty the Queen's Birthday Flypast on **8 June 2019**; rehearsals for this flypast will be held during the period **3 to 5 June 2019**. The rehearsals will start in the vicinity of Southwold, Suffolk then route via the overhead of Royal Air Force Marham, Norfolk and conclude, for dispersal, at Royal Air Force College Cranwell, Lincolnshire. Due to the large number of aircraft involved, the Secretary of State for Transport has decided that it is necessary to introduce Restriction of Flying Regulations under Article 239 of the Air Navigation Order 2016.

NOTE: FOLLOWING A SUCCESSFUL REHEARSAL, SUBSEQUENT REHEARSAL DAYS WILL BE CANCELLED BY NOTAM.

CHART AREA A

- 2** Subject to paragraph 5, between **1010 hours and 1200 hours on each day beginning with 3 June 2019 and ending on 5 June 2019** no aircraft is to fly below 10,000 FT AMSL within the area bounded by straight lines joining the following points:

- a) 525209N 0022026E;
- b) 523249N 0025026E;
- c) 522558N 0024447E;
- d) 520814N 0020909E;
- e) 520436N 0015041E;
- f) 522200N 0012000E; and
- g) 525209N 0022026E.

CHART AREA B

- 3** Subject to paragraph 5, between **1135 hours and 1205 hours on each day beginning with 3 June 2019 and ending on 5 June 2019** no aircraft is to fly below 7,000 FT AMSL within the area bounded by straight lines joining the following points:

- a) 524111N 0003539E;
- b) 522620N 0012700E;
- c) 522252N 0012010E;
- d) 523636N 0003222E; and
- e) 524111N 0003539E.

CHART AREA C

- 4** Subject to paragraph 5, between **1135 hours and 1215 hours on each day beginning with 3 June 2019 and ending on 5 June 2019** no aircraft is to fly below 3,000 FT AMSL within the area bounded by:

- a) straight lines joining successively the following points:
 - i. 531514N 0002624W;
 - ii. 530114N 0002114W;
 - iii. 524111N 0003539E;
 - iv. 523636N 0003222E;
 - v. 530332N 0004246W;
 - vi. 531459N 0004230W;
 - vii. 531619N 0004034W; and
- b) then the anti-clockwise arc of a circle having a radius of 5 NM whose centre is at 531828N 0003303W between 531619N 0004034W and 531514N 0002624W.

- 5** Paragraphs 2 to 4 above do not apply to any aircraft:
- a) flying in accordance with a clearance issued by:
 - i. Royal Air Force (Unit) Swanwick;
 - ii. the air traffic control units at:
 - 1. Royal Air Force Marham;
 - 2. Royal Air Force Waddington; or
 - 3. Royal Air Force Cranwell; or
 - b) operating in the service of the Maritime and Coastguard Agency; or
 - c) flying in accordance with a permission issued by the HQ AIR Queen's Birthday Flypast 2019 Project Officer who may be contacted on telephone number 01760-337261 extension 6664 or 6661.
- 6** These Restricted Areas (Temporary) (RA(T)) directly affect a number of Aerodrome Traffic Zones and also aerodromes/flying sites that do not have Aerodrome Traffic Zones. Aerodrome Operators and ATS Units affected by the RA(T) are requested to bring this Circular to the attention of their resident and local operators.
- 7** In relation to paragraphs 2 to 5, the term 'aircraft' includes aircraft as classified by Part 1 of Schedule 4 to the Air Navigation Order 2016. It also includes, by virtue of Article 23 of that Order, any small balloon, any kite weighing not more than two kilograms, any small unmanned aircraft and any parachute including a parascending parachute.
